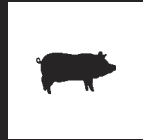

We will offer you that personal touch and will work with you to design an event, tailor-made to your individual requirements.

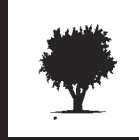
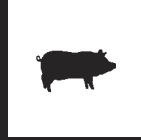

~Deposit ~

30% of the total bill is payable by cash, cheque or credit card, unless other arrangements are made.

~Final Numbers ~

Final confirmation of attendee numbers is to be received no later than 14 days prior to the function.

~Payment ~

Payment for your function will be 30% deposit at time of booking with the balance payable 14 days before the function.
A surcharge of 20% will apply for functions held on public holidays.
